**REQUEST FOR INFORMATION** – Information relating to the tendering process for the Pottery, Photographic Studio, Gwalia Stores and the Bakery at St Fagans for the past five years.

Thank you for your request for information. As Head of Knowledge & Information Management for Amgueddfa Cymru - National Museum Wales, I am responsible for responding to your request for information.

I refer to your email of 30 November 2012, in which you asked for the following information:

- 1) How each of the individual business tenders were advertised, where and for how long?
- 2) How many individual tender applications were made for each business?
- 3) Information within each tender.
- 4) The time frame of each tender process.
- The names and addresses of all tenders 5)

In responding to your request for information, I will be referring to each business separately.



#### **Gwalia Store**

Amgueddfa Cymru – National Museum Wales does not hold the information that you have requested as the business has not been tendered within the time period, therefore I am unable to provide the information as requested as it does not exist. Under Section 1.1 of the Act, the information you have requested is not held therefore, I must apply Section 17 of FOIA which states that where public authorities receive requests for information that they do not hold, they must issue a Refusal Notice stating they do not hold the requested information. I am therefore issuing you a Refusal Notice for information relating to tendering processes for Gwalia Stores. I am applying this Refusal Notice to questions 1 to 5 for the Gwalia Store.

### The Photographic Studio

1) How each of the individual business tender was advertised, where and for how long?

There was no advertisement; the Museum contacted 10 Studios to enquire if they would be interested in submitting an expression of interest.

Even thought the Museum did tender for this business, it was not obliged to carry out a formal tendering process as the value of the tender was under £ 15,000.

2) How many individual tender applications were made for each business?

Two tenders were received.

Your request for this information has been considered. Unfortunately, Amgueddfa Cymru is unable to provide the detailed information of the tenders as you have requested.

It is considered that the public interest in withholding the information outweighs the public interest in disclosing it. Therefore, in accordance with the Freedom of Information Act 2000, this letter acts as a Refusal Notice.

The exemption applied is Section 43(2) Commercial interests.

This exemption applies because the disclosure of the requested information would be likely to prejudice the commercial interests of the contract holder, Amgueddfa Cymru and all those who have supplied detailed tenders in any future negotiations.

We do not provide financial information on current tenders as we consider this information is commercially sensitive. The contract was only awarded in **November 2012** which makes this information very current thus very commercially sensitive. Disclosure of this current information is likely to prejudice all parties in future negotiations. Amgueddfa Cymru does not disclose current information which would likely prejudice the Museum's or other company's future negotiation opportunities. Such information is not released and exemption S.43(2) is applied.

Moreover, releasing such information would fetter the Museum's ability to obtain a competitive price on retendering i.e. disclosure would harm the Museum's ability to achieve best value when the contract is next retendered.

We acknowledge that there is a public interest in disclosure to support openness and transparency, especially relating to the spending of public money, but there are opposite and weightier interests in non-disclosure due to the importance of ensuring a level commercial playing field and achieving best value in negotiations for public sector contracts.

I have not provided the personal addresses as I believe this to be personal information as the information has not been noted as being a business address. I have applied section 40(2) to this information and therefore, the personal address for the two individuals has been withheld.

### Section 40 (2) FOIA – Personal data exempt from disclosure

The information requested amounts to personal data and is exempt under section 40(2), FOIA, as disclosure, without the consent of the individuals to whom it relates, to a member of the public otherwise than under the FOIA would breach the first data protection principles. This exemption is absolute and is not subject to the public interest test. Therefore, the information requested is exempt under FOIA section 40(2) and will now be reviewed under the Data Protection Act 1998 (DPA).

Data Protection Act 1998 (DPA)
Section 1(1) DPA – meaning of "personal data"
Information relating to personal addresses of those tendering which is personal data within the meaning of the DPA.

## Part I of Schedule 1 DPA – first data protection principle

In our view, the disclosure of personal data to a third party would be unfair within the meaning of the first data protection principle. Part II of Schedule 1 to the DPA

sets out how the principle of fairness is to be interpreted. It states that, in deciding whether personal data is processed fairly, regard must be had to whether any person from whom it was obtained is deceived or misled as to the purpose or purposes for which they are to be processed.


