REQUEST FOR INFORMATION – Information relating to filming at the Museum for Doctor Who

Thank you for your request for information. As Museum Secretary for Amgueddfa Cymru - National Museum Wales ('the Museum'), I am responsible for responding to your request for information.

I refer to your email of 13 December 2016, in which you asked for the following information:

...has the BBC conducted any filming at the museum for "Doctor Who" since 1 September 2016? If so, please provide any correspondence between the museum and the BBC relating to that filming.

RESPONSE

Yes the BBC has, since 1 September 2016, conducted filming at National Museum Cardiff, one of the eight national museums that make up the Museum.

NMGW Enterprises Ltd, the Museum's trading company, dealt with the BBC's filming arrangements. Therefore they hold the correspondence, rather than the Museum. Our response therefore will relate to that correspondence held between the BBC and NMGW Enterprises Ltd.

Appended to this letter is the correspondence that is not covered by an exemption. Certain third party information has been redacted from this information, in order that our response complies with the Data Protection Act 1998.

Section 43(2) – Commercial Interest

Section 43(2) of the Freedom of Information Act 2000 exempts information the disclosure of which would be likely to prejudice commercial interests. Although S.43 is subject to the public interest test, to which we have given careful consideration, we have decided that in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.

This exemption applies because the disclosure of the requested information would be likely to prejudice the commercial interests of both NMGW Enterprises Ltd and the BBC.

Section 40 (2) FOIA - Personal data exempt from disclosure

The information requested contains personal data and is exempt under section 40(2), FOIA, as disclosure, without the consent of the individuals to whom it relates, to a member of the public otherwise than under the FOIA would breach the first data protection principles. This exemption is absolute and is not subject to the public interest test. Therefore, the information requested is exempt under FOIA section 40(2) and will now be reviewed under the Data Protection Act 1998 (DPA).

Data Protection Act 1998 (DPA) Section 1(1) DPA – meaning of "personal data"

Information relating to the personal contact details of individuals included within the correspondence is personal data within the meaning of the DPA.

Part I of Schedule 1 DPA – first data protection principle

In our view, the disclosure of personal data to a third party would be unfair within the meaning of the first data protection principle. Part II of Schedule 1 to the DPA sets out how the principle of fairness is to be interpreted. It states that, in deciding whether personal data is processed fairly, regard must be had to whether any person from whom it was obtained is deceived or misled as to the purpose or purposes for which they are to be processed. In this case, the identity and personal contact details of the correspondents were provided for the sole purpose of completing negotiations around the contract, and for this reason, the principle of fairness, disclosure of the personal information would be unfair as the individual only provided the information for that purpose and not for public publication through an FOI response. For that reason the information is being withheld.

Your request was considered according to the principles set out in the National Assembly's Code of Practice on Public Access to Information (third edition). The Code is published on the Internet at www.information.wales.gov.uk.

If you believe that I have not applied the Code of Practice on Public Access to Information correctly or have not followed the relevant laws, please contact me to

request a first-stage review. If, after that, you are still not satisfied you may request a formal review by Amgueddfa Cymru. When dealing with any concerns, we will follow the principles of the National Museum of Wales's Code of Practice on Complaints, which is available on our website at https://museum.wales/freedom-of-information/publications-scheme/ or by post from:
