### What data do we collect?

### How do we collect your data?

We are collecting your data by means of questionnaires, recorded online meetings and social media responses. Not all responses will be by the same means, and some will provide responses by more than one means.

### How will we use your data?

For research purposes by finding out how we can improve our services, or what people will expect of our new website or to add to the knowledge and understanding of the exhibits and collections of the Museum.

The legal basis for the processing of your data during the project will be as part of our Public Task. Once the project is completed, the data will be added to the Museum archive under the Archiving in the Public Interest basis

### How do we store your data?

Your data will be stored securely, in line with current Data Protection legislation and we will ensure that your personal information is managed securely. Access to and use of your information will be limited to authorised staff.

## Sharing Your Data

We won't share your details with any third party organisations for Marketing or Sales purposes. We will only pass your data to third parties to help us with the Contemporary Art Website Consultation, and they will only be able to use your data for this purpose and nothing else.

## What are your data protection rights?

We will be able to provide you with a copy of your data with you if you have provided us with your contact details. It will be possible for you to amend or delete this data during the consultation process which will come to an end on 31 October 2021. We won't be able to change your data after this date as the purpose of this consultation is to gain a snapshot of the respondents during this period.
