Introduction

The Collection Development Strategy supports the delivery of Amgueddfa Cymru 2030, Widening Engagement Action Plan, Green Land Management Plan, and our responsibilities towards delivering the Wellbeing of Future Generations Act, Welsh Government's LGBTQ+ Action Plan and Anti-Racist Wales Action Plan, Welsh Government's Sporting Heritage Framework for Wales, our statutory responsibilities in relation to the Treasure Act, the Programme for Government, and Remit Letter.

Amgueddfa Cymru's collection is multidisciplinary and is unique in its range and breadth across the Natural Sciences – botany, geology and zoology; History and Archaeology – contemporary, social, industrial and architectural, and community archaeology; Art incorporates design, applied art, photography, historic, modernist and contemporary art. We also have library, archive, oral history and audio-visual collections that cover a range of different areas across the collection disciplines.

The strategy aims to support a greater diversity of collecting across all disciplines, with a new focus on acquisitions and commissioning, supporting more diverse representation in decision making about what and how we collect, and increasing access to collections physically, intellectually, and digitally.

The Covid 19 pandemic, the pressing impact of the climate emergency, and the murder of George Floyd changed the ways in which we engage with and support our visitors to deliver social benefit. This opened up new questions about the collection and how we collect with the people of Wales to make sure that everyone is represented, that everyone has a voice and that we adequately represent the natural environment in the collection.

Our Strategy, Amgueddfa Cymru 2030, sets out our commitment to ensuring that everyone in Wales can shape and participate in the development of the national collection. We recognise our responsibility to focus our work with those who do not yet see themselves adequately represented in the collection. We also recognise the value of collaborative working to collect specimens to represent the natural environment in Wales.

Through prioritizing our collection development areas, we will support the achievement of our Strategy's six commitments to Wales. We will work with communities to make sure that everyone is represented within the collection. Diversifying the collection and increasing representation will inspire creativity and learning for life. We will contribute to internationally important work to help safeguard and restore nature and our natural environment through collaborative working and acquisition of strategically important specimens.

We will review collection priority areas to ensure that they can support wellbeing through inspirational spaces and experiences, with accessibility at their core. Digitising priority collecting areas and collecting born digital material will help visitors to discover and explore the collection digitally and create new digital content. Finally, we will build global connections through our collection to ensure that communities both within Wales and internationally collaborate in its development.

Our Collecting Methodologies - how we collect and develop the collection

Cultural democracy is at the heart of developing the collection. We will work collaboratively with communities as co-curators, collectors and decision makers. We'll actively support communities who experience inequalities or racism, by supporting the delivery of the Welsh Government's Race Equality, LGBTQ+ and other equality action plans. These policies will provide clear focus for future collecting.

We will build on existing ways of collecting and develop new methodologies that ensure that we actively engage individuals and communities across Wales in deciding what and how we should collect. Working in partnership with diverse communities, and local and national organisations, we will prioritise the development of community-led practice in the following areas:

- **Commissioning.** Building on the commissioning model developed through the Reframing Picton project, we will reframe and refocus the commissioning process to support a diverse range of practitioners to respond to existing collections and create new works.
- **Oral history.** We will develop training hubs for community oral history and build on the collaborative approach of the Windrush model to supporting communities to record and tell their own stories. We will extend oral history to diversify and record stories that are relevant across all our collecting disciplines.
- **Rapid response collecting.** Building on our work to collaboratively collect the material culture of the BLM movement, and the Collecting Covid Initiative, we will develop processes that support community led collecting in response to rapid socio-political and economic changes in society. We will also target rapid response collecting of threatened archaeology and natural history, in particular geological specimens, where it would be otherwise destroyed. In addition, we will respond quickly to acquire nationally significant and star objects for the collection when appropriate and where possible.
- **Deliver the Decolonising Charter.** We will pilot and experiment with collaborative ways of working with a range of diverse communities to develop deeper and multiple meanings. In collaboration with our community partners, we will identify objects that support the delivery of a more balanced, authentic and decolonised account of history.

- **Develop existing collections.** With communities of relevance, we will reframe and reclassify existing collections to increase their relevance, visibility and accessibility. These will include disability representation, LGBTQ+, and collections that can support people living with dementia. Making more of our existing collection will extend to amplifying objects of significant importance and increasing their reach and impact.
- **Community archaeology.** Supported by the Portable Antiquities Scheme and Treasure Act, we will shift the focus from what we collect to focus on how we support communities to find archaeology on their doorsteps in partnership with local museums and other organisations.
- **Natural sciences partnerships.** Through strengthened partnerships with National Resources Wales, National Botanic Garden and third sector bodies such Wildlife Trusts, National Parks, Buglife and Plantlife, we will create opportunities for public involvement.
- **Use our sites across Wales.** We will develop our collections to ensure a greater range of material is available to support and tell more diverse stories across our sites. Collect with communities to support delivery of Amgueddfa Cymru strategic objectives. Greater diversity of collecting will be visible at all sites
- **Distributed national collection model.** We will work more collaboratively with Museums Federation Cymru (and other organisations across Wales to ensure the development of a distributed national collection.

Sustainable collecting

- Re-homing objects

As the national collection continues to evolve, we have a responsibility to actively and critically review the collections we already have. We have already initiated a pilot collection rationalization programme which focuses on the public benefit that can be derived from underused objects in our collections through re-homing them. The aim is to give these objects a new 'lease of life' through being displayed and/or used in different contexts where they can once again be enjoyed by the public. Our priority is to re-home to organisations in Wales that operate in learning and the third sector, such as museums, schools, social enterprises, community groups and health and well-being settings such as care homes. Communities are at the centre of our decision-making.

We will also review our natural science collections to identify material which does not fit with our collecting priorities and identify suitable museums or collection-holding research bodies who can use them more productively with relevant expertise to produce new research.

- **Increasing accessibility**

We have about 5.2m items in our collection of which only about 30,000 are regularly accessible to the public through exhibition and display, either at our sites or through loan to third party venues. Although anyone can ask to see items in our stored collections, we want to make it easier for people, especially those who live throughout Wales, to use and enjoy our collections. To ensure these are physically accessible, we need to fully consider the long-term care and storage implications of the items we collect at the point that we collect them. We need to recognize the challenges of conserving certain types of material, for example plastics, and actively challenge prevailing orthodoxies that everything must be kept in perpetuity. It is also important we recognise that actively using an object now can be more beneficial than preserving it in its current state for an undefined future use. It is essential that we are open and honest about why we collect, and plan ways in which our existing collections have greater use. To achieve this, we will:

- Expand and embed our pilot rationalisation programme
- Create a framework for actively involving the communities we collect from in decisions regarding the use, care and conservation of the items we have collected from them
- Consider the access and learning needs of diverse users as opportunities arise to refurbish or expand collection storage

Digital access

As not everyone is able to physically engage with our collections, we need to continue to develop digital access to our collections. We need to continue to capture and record as much information as we can about the items we collect at the point we collect them - in both our collection management system and digital asset library. As these digital assets are the building blocks for all digital access to our collections, the quality of the platforms we then build is entirely dependent on the quality of these assets. Our primary platform for digital publication is our on-line catalogue Collections Online. We want this, and any associated platforms that we develop (for example the contemporary art website), to reflect the diverse voices of the communities of Wales.

To do this, we will:

- Develop classifications of relevance through our decolonising work
- Develop user-focused key words, building on the work initiated through the Contemporary Art Digitisation Project
- Prioritise a programme to make natural science specimens accessible on-line by diverse audiences
- Work with our Community Action Researchers to incorporate community voices into our collection management systems

- Prioritise digitising collection areas that support representation, decolonisation and the climate emergency, and add this content to Collections Online as the gateway to developing associated dedicated platforms
- Develop on-line geographical referencing of specimens from Wales (i.e., GIS or co-ordinate-based presentation)

Collection priorities

The strategy recognises that Amgueddfa Cymru has limited resources. It therefore focuses on the areas where we will prioritise our collecting activity over the next 5 years. The purpose of developing the collection is to ensure that it can directly support the following commitments in Amgueddfa Cymru 2030:

- Make sure that everyone is represented
- Help protect and restore nature and our environment
- Inspire creativity and learning for life

In addition, the strategy will support the following commitments:

- Support well-being through inspirational spaces and experiences
- Discover and explore the museum digitally
- Build global connections

We will also give particular emphasis to collections that support the cross-cutting research themes in the Research Strategy.

Decolonisation, Inclusion, Environmental protection and sustainability and Cynefin.

Alignment with other Amgueddfa Cymru strategies and policies

This strategy is aligned with Amgueddfa Cymru's Strategy for Public Programmes and Research Strategy. It aims to support the delivery of some of Amgueddfa Cymru's Public Programmes. Some programmes outlined in the Public Programmes strategy can also generate collecting in new areas with new audiences of relevance. The Collection Development Strategy also aligns closely to the Research Strategy, as new collaborative research methodologies bring new and deeper meaning to existing and new collections. This approach will strengthen working across museum departments and bring coherence to future collecting and research initiatives and funding applications.

Whilst the Collection Development Strategy sets out why and how we will collect, the Collection Development Policy, which is a requirement of Museum Accreditation, provides more details about what we collect. Our collecting activity is further supported by a suite of public-facing collection care and management policies and internally focused procedures.

Aims and Impacts

The following aims will be developed as priorities to support the commitments in Amgueddfa Cymru 2030. Intended impacts and a sample of activities have also been outlined.
